

Subject: Declaration for the purposes of Regulation (EC) no. 1907/2006 - REACH and SCIP Notification.

Dear Customer,

concerning the obligation referred to in Article 33 of the REACH Regulation n. 1907/2006 ("Obligation to communicate information on substances contained in Articles"), Pietro Fiorentini SpA declares that in the Items listed below, some SVHC substances (as indicated in Candidate List ECHA https://echa.europa.eu/it/candidate-list-table) are present in quantities greater than 0.1% by weight, in particular lead (CAS No. 7439-92-1).

For the Articles indicated below, the SCIP Notification was made pursuant to the Waste Directive 851/2018/EU.
